COVID Positive Close Contacts and Symptom Testing Procedures for EMS Personnel

Please use the following procedures for testing your EMS staff when they are identified as Close Contacts to a COVID positive case and/or are experiencing COVID symptoms.

Unvaccinated COVID weekly screening testing is no longer required.

For symptomatic staff:

- Wear a mask.
- o Go home.
- Test via antigen testing at first sign of symptoms (Day 0).
 - If positive, isolate at home for a minimum of 5 additional days.
 - If on or after Day 5 symptoms are improved and no fever has been present for at least 24 hours, repeat antigen test.
 - If positive, continue to isolate through Day 10. You may return to work on Day 11, if symptoms have improved and no fever has been present for at least 24 hours.
 - If negative, you may return to work on or after Day 6.
 Continue to wear a mask until Day 10.
 - If negative, repeat antigen test at 48 hours.
 - If negative, you are cleared of COVID. However, you are directed to stay home until symptoms improve and no fever is present for at least 24 hours.
 - If positive, isolate at home at least through Day 5.
 - If on or after Day 5 symptoms are improved and no fever has been present for at least 24 hours, repeat antigen test.

- If positive, continue to isolate through Day 10. You may return to work on Day 11, if symptoms have improved and no fever has been present for at least 24 hours.
- If negative, you may return to work on or after Day 6. Continue to wear a mask until Day 10.
- For Close Contacts (someone who was unmasked and less than 6 feet away from a confirmed COVID positive case for a total of 15 minutes or more over a 24-hour period):
 - Wear a mask for 10 days following exposure.
 - If symptomatic, test immediately and follow the steps above for symptomatic staff.
 - o If asymptomatic:
 - Test via antigen testing on Day 5.
 - If positive, isolate at home through Day 10. You may return to work on Day 11.
 - If negative, no additional testing is required unless symptoms develop.
- For outbreaks (3 or more COVID positive staff members at a single location):
 - Notify EMS Coordinator, Rachel Oakley, at <u>roakley@co.slo.ca.us</u>.
 - All staff are required to wear a mask.
 - All staff at the location test via antigen testing on Day zero or the day you learn that there are 3 or more positive cases at a single location.
 - o All staff test again on Day 3 or 4 and Day 7 via antigen testing.
 - If additional positives emerge, repeat antigen tesing for all staff twice weekly, until you have no additional positives over a 7 day span.
 - When there are no additional positives over a 7 day span, your location is cleared of outbreak status.
 - Notify and confirm with EMS Coordinator, Rachel Oakley, of cleared status by reporting the last positive test date and the following two negative test dates over a 7 day span.
