**ELIZABETH MERSON** PHEP REPORT

- The Public Point of Distribution (PPOD)/flu shot exercise took place on October 21<sup>,</sup> 2018. Public Health (PH) • partnered with Five Cities Fire Authority and the City of Atascadero to administer 861 vaccines at 2 sites.
- PH will be participating in the Emergency Worker and Decon training/drill with OES on January 9, 16, and March 27, 2019
- PHEP has written a Disaster Responder Health and Safety Guide for pre, during, and post deployment to • monitor the physical and mental health of responders. - PHEP will be participating in a short presentation at Health Commission meeting on "Spanish Flu: 100 years later" on January 14<sup>th</sup> at 6pm at the BOS Chambers: 1055 Monterey St, San Luis Obispo. The presentation will be live on SLO Span and via web streaming.
- PHEP revised the Public and First Responder POD Standard Operating Procedures (SOPs) in order to ٠ consolidate positions. The revised SOP was tested during the October PPOD exercise and the new positions worked well.

The tri-counties plan on continuing cross-jurisdictional training to ensure a seamless response when the counties provide mutual aid support to each other.</li> </ul>
	<ul> <li>EMS Duty Officer Program – Med/health partners are encouraged to reach out if they are impacted (surge of patients, infrastructure impacts), so EMS can monitor and support the overall med/health system.</li> <li>PH/EMS cannot request program flexes, but they can advocate for med/health partners.</li> </ul>

Behavioral Health	<ul> <li>supply at a time.</li> <li>In October formed partnership with Tenet Health to have a full time clinician (40 hr/week) embedded in the Emergency Room at each hospital.</li> <li>4 are clinicians working with SLO City PD and the Sheriff's Office to enhance mobile services; plan to expand partnership to Atascadero and Paso Robles to enhance services to North County soon.</li> </ul>
	<ul> <li>To address MH surge, BH is looking to build workforce by building public/private partnerships.</li> <li>Eric R. – French receives many of psych crisis patients.</li> </ul>
	<ul> <li>Anne – Patients in psychiatric crisis often have co-existing medical ailments and need a medical assessment. The PHF is not licensed to perform medical assessments (can only do first aid) so patients must go to ER. There are not enough psych beds statewide, so there are delays in placing psych patients. BH is working on contract for psych patient transportation, which will hopefully help throughput. Vista Del Mar reopened so there are more pediatric beds available in the state. Psych beds in SLO County are only for adult MediCal patient—patients with private insurance and all pediatric patients have to go out of county for services.</li> </ul>
PARTNER REPORTS	<ul> <li>Tina/Cal Poly Health Center: Cal Poly has new student fees for health services. This has increased BH staff and other health services such as free flu vaccines.</li> </ul>
	<ul> <li>Kerry/SLO Fire Dept: Tested red phone with OES this morning and it was a successful drill</li> </ul>
	<ul> <li>Daniel/Cal Poly: Conducted EOC drills in December. Tested both "Green" and "Gold" teams. AAR will be ready by end of the month.</li> </ul>
	<ul> <li>Health Commission- Health Commission will include a presentation on the 100 year anniversary of the Spanish Influenza on January 14<sup>th</sup> at 6pm. Looking to including emergency preparedness on a future agenda.</li> </ul>






# The California Camp Fire: Event Timeline & Impact

4

- Over the next week the fire burned nearly 50 square miles, destroying ~19,000 structures and causing widespread air pollution in the Central Valley and San Francisco Bay area
  - Fire not fully contained until November 25<sup>th</sup>
  - Total of 85 fatalities, with 11 still missing



# The California Camp Fire: Healthcare System Impacts

Evacuations	Impacts to Staff	Patient Surge Due to Air Quality
<ul> <li>Adventist Health Feather River Hospital (Paradise); unclear if hospital can be repaired</li> <li>All 3 skilled nursing facilities in Paradise also had to be evacuated</li> </ul>	<ul> <li>Majority of Feather River's 1000 FT and PT staff lost their homes</li> <li>Enloe Medical Center (Chico) – nearly 300 staff (of 3,500) lost their homes</li> <li>Oroville Hospital (south of Paradise) – nearly 80 staff (of 1,600 total) lost their homes</li> </ul>	<ul> <li>Asthmatics, elderly, children, and those with chronic conditions most at risk</li> <li>Surge in ED visits during fire and elevated rates in 2-3 weeks after due to cumulative impacts of poor air quality</li> </ul>
